- The child will be dropped off at their destination as the coach arrives. It is the responsibility of the legal guardian to ensure that somebody is there to meet unaccompanied minors. The coach will not wait and will leave as per its schedule
- The driver will act in accordance with the stated 'Unaccompanied Minor' policy
- Children will not be supervised by the driver during refreshments stops. It is the unaccompanied minor's responsibility to ensure that they get back on the coach on time
- InterCity, GreatSights & Newmans Coachlines cannot be responsible for unaccompanied minors during transfers and inter service transfers
- No amendment to the journey destination will be accepted unless confirmed by the parent/guardian

I/We the undersigned, being the legal guardians of the minor mentioned below, request InterCity, GreatSights and Newmans Coachlines to accept for carriage as passenger(s) upon the service specified as an unaccompanied minor. I/we have read and understand the stated unaccompanied minor policy (overleaf). InterCity Coachlines, GreatSights and Newmans Coach Lines conditions apply to the carriage of passengers and baggage. I/we agree to and shall assure to InterCity, GreatSights and Newmans Coachlines all the protection and benefits reserved to or conferred upon InterCity Coach Lines, GreatSights and Newmans Coachlines by such conditions. I/we indemnify InterCity, GreatSights and Newmans Coach Lines against all actions, proceedings, claims, demands, costs or expenses incurred either directly or arising out of any non-compliance by the said unaccompanied minor with any of the said conditions. I/we hereby state that the minor is seven years of age or over.
